INTRODUCTION

The Workshop on VISION was created to play an integrative role in the WSSE, since it comprehends all aspects and dimensions of socioeconomic activities that are based on solidarity and on a cooperative relationship between socioeconomic agents. It encompasses themes like *development, self- and co-management, labor emancipation, empowerment, democracy, the role of Society and the State, sustainability, people's governance, solidarity collaborative networks, solidarity productive chains, competition versus cooperation, the firm's economic efficiency versus the systemic socioeconomic efficiency, economic relations between masculine and feminine, etc.*

Participants include activists and academics from Africa, Asia, Europe, Latin America and North America of different backgrounds and professions, some of whom have been collaborating with each other or participate in solidarity networks for years. The founding members made explicit that the Workshop on VISION should include grassroots workers who are living a solidarity economy in their daily practice and can contribute to the Workshop's conceptual construction.

The Workshop on VISION recognizes other groups and networks working on a Solidarity Economy and intends to facilitate the dialogue with them and among them. Since the VISION is related to a critique of the existing capital-centered development paradigm and the establishment of a people- and eco-centered development paradigm, it has a transversal nature and must interact with all other workshops in the WSSE, and other Workgroups and Colleges in the Alliance 21. Particularly concerned are Gender and the Economy, Integrated Development Projects, Subsidiarity, International Regulations, Social Money, Social Responsibility, Equitable Trade, Social Responsibility, Agriculture, Global Governance, Environmental Justice and Ecological Debt, Poverty and Livelihood, Stockholders, Entrepreneurs, Fisherpeople.

MAIN GOAL

To establish a creative dialogue between different ways and methods of conceiving and developing SSE, in the WSSE, in the Alliance21 and with other

networks as a means to facilitate the empowerment of persons, communities and peoples for the purpose of becoming the subjects of economic and technical development as a basis for the development of their own individual and collective attributes and potentials.

SPECIFIC GOALS (SP)

- A. Distinguish between the universal basic values that should guide every SSE practice and the concrete ways and methods of building those practices, which should be respected in their diversity and uniqueness, and should build synergies through interaction with each other in the form of always broader and more encompassing collaborative networks.
- B. Offer theoretical and conceptual instruments for renewed economic practices of women and men workers.
- C. Contribute to the design of local, national and global legislation that foster new systems of governance based on people's participation.
- D. Promote SSE as part of the agenda of social movements and other civil society organizations and networks, and to collaborate with social groups and networks around the world already working on a SSE.
- E. Contribute to the promotion of the right of local communities to an ethical and sustainable livelihood and to their local knowledge and on associative control over local consumption, production, financial and trade systems.
- F. Contribute to awareness raising of lavish consumers by linking their consumption and life style patterns with the food insecurity and growing destruction of ecosystems.
- G. Mutually strengthen transversality among all Alliance21 workshops, as well as other groups working on solidarity socioeconomy-related issues, through knowledge sharing and information exchange.
